PROGRAM OVERVIEW



TEACHUNITED PROVIDES:

- Collaborative development of a monitoring and evaluation plan, including a platform for data collection, management, storage and reporting.
- A Tableau login to view and share data. After Phase 2, Tableau costs would be covered either by the partner or TU will provide off-ramp instructions for alternative systems.
- Digital and paper assessments for assessing teacher and student practices, attitudes, knowledge, and beliefs that can be used by the partner post-program as well.
- During the program, digital and paper student assessments when appropriate.
- Strategies for sharing results with partner schools, districts, and communities

- Plan a data collection schedule that works for you
- Discuss and analyze results





SAMPLE SCHEDULE

Pre-Program

- M&E Discovery Meeting

During Program Year 1:

- M&E Session 1: Organization M&E history and capacity building
- M&E Session 2: Metrics that Matter
- M&E Session 3: Assessments and Data. Also sharing TU implementation metrics, including participation in online course, webinars, coaching calls, and exit tickets.
- M&E Session 4: Planning for Data Collection
- Deliverable: Post Phase 1 Implementation and Survey Results
- Deliverable: Tableau Login and Access

During Program Year 2:

- Ongoing: Tableau maintenance and support
- M&E Session 5: Implementation of Data Plan
- M&E Session 6: Analysis, Visualization, and Results Sharing
- M&E Session 7: Planning for M&E Improvements

Post-Program:

- “Offramp” Support: Instructions for partners to take over the M&E data collection and storage, including survey instruments.
- Deliverable: End of program report and recommendations for future M&E work

SUSTAINABILITY

At the end of the 2 year partnership, the partner will have an organizational M&E plan, data collection schedules, recommended instruments, and the ability to analyze and share data on their own systems. If the partner chooses not to continue with Tableau as its analysis and reporting platform, TeachUNITED will provide recommendations for free alternatives and help ensure data is downloaded upon completion of the program.
